Medical Director, Utah Poison Control Center

The Utah Poison Control Center (UPCC) is seeking a medical director, in affiliation with the Division of Emergency Medicine (DEM) at the University of Utah in Salt Lake City and Emergency Physician Integrated Care, LLC (EPIC). The medical director will serve as a clinical faculty member in pharmacotherapy and emergency medicine at the instructor/assistant or associate professor rank. The position will be split ~ 75% UPCC and ~ 25% emergency medicine clinical practice. Qualified candidates must be board certified in emergency medicine and either board certified or board eligible in medical toxicology.

The University of Utah is the primary medical teaching and research institution in the state. The UPCC is administratively housed in the Department of Pharmacotherapy, College of Pharmacy, and serves the entire state of Utah. Established in 1954, it has one of the highest utilizations of any poison center in the US at twice the national average. The UPCC employs a multidisciplinary staff that plays a key role in the education of pharmacy students, EM residents, and pediatric EM fellows. The UPCC is an integral part of Utah's public health infrastructure. The Division of Emergency Medicine full-time faculty are trained in emergency medicine and certified by the American Board of Emergency Medicine. The division oversees the University of Utah Affiliated Emergency Medicine Residency program in addition to operating the AirMed helicopter service, three regional EMS systems, and multiple fellowship programs. EPIC is a group of emergency care providers whose mission is *to provide quality emergency medical care in an efficient, cost effective, compassionate and ethical manner, and in a way that promotes the interest of their patients and members*. EPIC staffs 15 hospital emergency departments along the Wasatch front as well as two freestanding emergency care facilities. It is run by board certified emergency medicine physicians. A very competitive salary with an excellent benefits package is offered.
